QUITCLAIM DEED

KNOW ALL PERSONS BY THESE PRESENTS: That WHEREAS, the BOARD OF TRUSTEES OF THE INTERNAL IMPROVEMENT TRUST FUND OF THE STATE OF FLORIDA, is by Section 253.03, Florida Statutes, authorized and empowered to convey certain lands under the terms and conditions set forth herein; and,

WHEREAS, said BOARD OF TRUSTEES OF THE INTERNAL IMPROVEMENT TRUST FUND OF THE STATE OF FLORIDA did approve this transfer on the 23rd day of July, 1991.

NOW, THEREFORE, the undersigned BOARD OF TRUSTEES OF THE INTERNAL IMPROVEMENT TRUST FUND OF THE STATE OF FLORIDA, whose address is The Capitol, Tallahassee, Florida 32399, Grantor, under authority of law, pursuant to Section 253.03, Florida Statutes, for and in consideration of the sum of Ten Dollars (\$10.00), and other good and valuable consideration, to it in hand paid by THE UNITED STATES OF AMERICA, acting by and through The National Park Service, Grantee, whose address is 1849 C Street NW, Washington, DC 20240, has remised, released and quitclaimed and by these presents does remise, release, and quitclaim unto said Grantee, its successors and assigns forever, the following described lands in Miami-Dade County, Florida, to wit:


THE LANDS DESCRIBED IN EXHIBIT "A" are for the use and benefit of the National Park Service of the Department of the Interior for the Everglades National Park Expansion.

SAVING AND RESERVING unto Grantor and its successors an undivided three-fourths interest in, and title in and to an undivided three-fourths interest in, all the phosphate, minerals, and metals that are or may be in, on, or under the said land and an undivided one-half interest in all the petroleum that is or may be in, on, or under the said land. However, as to such mineral and petroleum reservations, the right of entry is hereby released pursuant to Section 270.11, Florida Statutes.

TO HAVE AND TO HOLD the above-described premises for public recreational purposes subject to outstanding easements, reservations and other interests appearing of record. This grant is given with the express understanding that if the above described lands are not used for purposes of the Everglades National Park as provided by law, or if the above described lands are otherwise abandoned by Grantee, then in either of those events, title to said lands will automatically revert to Grantor.
